- Bylaws require that the GK, DGK, and Treasurer be authorized to sign checks on all council accounts. Motion to approve authorization was made by the GK and all agreed.
 - The GK and the FS announced that they will not stand for re-election next year; members were encouraged to consider volunteering for these positions over the coming year. The chancellor suggested that an apprenticeship period may be useful and these are challenging jobs to undertake.

FINANCIAL AND COMMITTEE REPORTS:

Treasurer's Report: With interest income of \$0.87, the balance in the Fr. Seamus fund is \$10269.82 as of 05/31/20. Transfer of the \$1588 dinner net profit from the council account and scholarship checks written in the amount of \$4450 to CPS and \$1550 to SJA brings the scholarship fund balance down to \$5857.82. The general fund at last report was \$7760.89. Income was \$500.00 (Food for Families); expenses were \$2963.08 (\$1024 state per capita, \$160.50 kiosk pamphlets, \$190.58 FS supplies and mailing expenses, and the transfer of the \$1588 Fr Seamus dinner net profit to the Fr Seamus account), leaving a balance of \$5298.54.
